## **Substrate Quality**

The concrete substrate must be sound and of sufficient compressive strength (minimum 25 N/mm²) with a minimum pull off strength of 1.5 N/mm².

The substrate must be clean, dry and free of all contaminants such as dirt, oil, grease, coatings and surface treatments, etc.

If in doubt apply a test area first.

#### **Substrate Preparation**

Concrete substrates must be prepared mechanically using abrasive blast cleaning or scarifying equipment to remove cement laitance and achieve an open textured surface.

Weak concrete must be removed and surface defects such as blowholes and voids must be fully exposed.

Repairs to the substrate, filling of blowholes/voids and surface levelling must be carried out using appropriate products from the Sikafloor<sup>®</sup>, SikaDur<sup>®</sup> and SikaGard<sup>®</sup> range of materials.

The concrete or screed substrate has to be primed or levelled in order to achieve an even surface.

High spots must be removed by e.g. grinding.

All dust, loose and friable material must be completely removed from all surfaces before application of the product, preferably by brush and/or vacuum.

Mixing Time	Prior to mixing, stir part A mechanically. When all of part B has been added to part A, mix continuously for 3 minutes until a uniform mix has been achieved.  To ensure thorough mixing pour materials into another container and mix again to achieve a consistent mix.  Over mixing must be avoided to minimise air entrainment.		
Mixing Tools	Sikafloor®-2420 must be thoroughly mixed using a low speed electric stirrer (300 - 400 rpm) or other suitable equipment.		
Application Method / Tools	Prior to application, confirm substrate moisture content, relative humidity and dew point.  If > 4% pbw moisture content, Sikafloor® EpoCem® may be applied as a T.M.B. (temporary moisture barrier) system.  Primer:  Make sure that a continuous, pore free coat covers the substrate. Always apply the 1st coat of Sikafloor®-2420 by brush. # Notes on Application / Limitations

Do not apply Sikafloor®-2420 on substrates with rising moisture.

Freshly applied Sikafloor®-2420 must be protected from damp, condensation and water for at least 24 hours.

For external applications, apply on a falling temperature. If applied during rising temperatures "pin holing" may occur from rising air.

Under certain conditions, underfloor heating or high ambient temperatures combined with high point loading, may lead to imprints in the resin.

If heating is required do not use gas, oil, paraffin or other fossil fuel heaters, these produce large quantities of both CO<sub>2</sub> and H<sub>2</sub>O water vapour, which may adversely affect the finish. For heating use only electric powered warm air blower systems.


